**Drug Screening Information Handout**

- You must provide an initial drug test within 5 business days of the resolution of your incident.
- During your probationary period, as sanctioned by the Office of Student Conduct, you will be required to attend random drug screenings.
- You will be notified by email on the day you have selected to be drug tested:
  - Email: You choose the day of the week on which you want to be drug tested (Tuesday through Thursday). You will be contacted by email on the morning (by 9:00 am) when you must attend a random drug screening. *Plan to check your email shortly after 9:00 a.m.* **It will be necessary to check your email each week on the designated day; however, you will only receive an email if you need to get a drug test. You must attend your drug screening on the day you receive the email from our office.** If you are to be tested on a given day you will be required to get a drug screening *that day*, during the hours specified below, to take your drug test. Failure to attend your designated drug screening could result in additional charges and sanctions under the Code of Student Conduct, including suspension from the university.
- Attending the drug screening:
  - Drug Testing Facilities are listed on the back of this page, along with times, prices, and locations.
  - **NOTE: The \$35/54 charge for the drug test is NOT covered by your \$100 service fee.**
  - If you take any prescription drugs please be sure to take your prescriptions with you to your drug screening. Make sure to show your prescriptions to the person administering your test so that they may note that those particular drugs may show up in your screening.
  - Drug tests screen for a variety of drugs including alcohol. A positive drug test for alcohol would be considered a positive drug test and a violation of your probationary status.
  - Please be aware that drug test results indicate a person's creatinine level. High creatinine levels indicate a pure test while low amounts of creatinine in the urine indicate a manipulated test, either through the addition of water in the sample or by drinking excessive amounts of water. **If your drug test reports a "dilute specimen" (creatinine level of <40) you will be required to immediately take another test. You will be responsible for paying for the additional test as well.**
  - **Two diluted drug tests would constitute a positive drug test.**
  - **Your drug screen results will need to be provided directly to the Office of Student Conduct by the drug testing location with your proper signature of release. You will need to arrange to have the results forwarded directly to our office from the drug testing facility on the results. Our fax number is 828-262-4997.**

### **Additional Information:**

**NOTE: The \$35/54 charge for the drug test is NOT covered by your \$100 service fee.**

The Office of Student Conduct will not accept results of “Rapid Response,” “E-Screen,” or “In-House” drug tests. All tests must be sent to a lab to obtain results.

Do not call the testing facility for your results!! They will call you in the event you test positive for any drugs or alcohol. Just assume that no news is good news.

The above-information is provided as a service to you; however, it is your responsibility to ascertain that the facility is open and that a drug test can be obtained on a given day. The Office of Student Conduct is not responsible for any changes in this information. Inability to obtain a drug test at one of the above-facilities will not excuse you from getting a drug test on the required day.
